

The gentleman had gotten worked up and broke some cups. He then struck a customer. I am filing a complaint.</p> <p data-bbox="609 987 1453 1165">—Mr. Jean-Paul Cochet, 38 years of age, residing at 80 Allée Jean-Jaurès in Toulouse-31, then presented himself and said: "I was assaulted by an individual in a frenzy; it was the same person who had just been in a dispute with the owner of the Hotel. I am filing a complaint against him.</p> <p data-bbox="609 1176 1461 1312">—We stopped and questioned the perpetrator of these acts who said that his name was Omar Moussaoui, born 01 January 1937 in Morocco, without further comment. Unemployed. I, the undersigned, Doctor Pierre-Marie Bras, Medical Examiner, Expert for the Court of Appeals in TOULOUSE, hereby certify that I personally examined the individual stating that he is named Jean Paul Cochet, born on 17 July 1955, and residing at 11, Rue Emile Guyou -31400 TOULOUSE.

The examination was conducted on 7 December 1993.

Mr. Cochet said that he had been assaulted on 7 December 1993 around 8:45 a.m., punched and kicked, his attacker also having attempted strangulation.

Since the events, he complained of headaches, throat pain with difficulty swallowing and difficulty speaking as well as pain to the right side of the chest.

The antecedents are represented by multi-trauma suffered in 1986 during an accident on a public roadway.

Under examination:

Height: 1.80 meters, weight 76 kg

Cervical marks corresponding to the strangulation indicated by Mr. Cochet, in the form of two parallel lines corresponding to skin abrasions on the anterior and lateral sides of the neck, accompanied by the appearance of diffuse erythematous.

Edematous reaction in neck area with respect to the laryngeal cartilage.

Diffuse pain with pressure to the right hemithorax with sharp point on interior arc of the 8th rib, without objective clinical defect.

Pain with diffuse hematoma to external genitalia towards the left side of the groin.

Thoracic x-rays show no rib fracture.

Temporary Total Disability in the criminal sense of the term is TEN DAYS.
