**ATTORNEY ADMISSION PROCEDURES
ALEXANDRIA DIVISION**

(Revised 12/01/2023)

Applicants are required to take the Oath of Admission in open court before any of the judges. An attorney previously admitted to practice in the Eastern District of Virginia must accompany the applicant and make an oral motion the applicant's admission.

Attorney Admissions are scheduled proceedings taking place on Tuesdays before the duty docket. Admissions are being scheduled for in-person hearings. *The day and manner of hearing are at the judge's discretion, as well as subject to change.*

Walk-in requests are not accepted at this time.

To be scheduled for admission an applicant must submit to the clerk's office, by mail or clerk's office drop box, the following:

- The completed application with a notarized original signature
- Original signatures of 2 attorneys already admitted to practice in this court
- Oath page signed with original signature (the requirement of in person signing is waived)
- Copy of Virginia Bar Card
- \$199 admission fee (checks or money orders only)
- \$21 fee for Certificate of Good Standing if requested

All signatures must be original. Photocopied, stamped, or computer-generated signatures will not be accepted.
