ATTORNEY ADMISSION PROCEDURES DURING COVID RESTRICTIONS ALEXANDRIA DIVISION

Applicants are required to take the Oath of Admission in open court (or Zoom hearing) before any of the judges. An attorney previously admitted to practice in the Eastern District of Virginia must accompany the applicant and make an oral motion the applicant's admission.

Because of restrictions placed on the court due to COVID, all attorney admissions will be scheduled. Walk-in requests are not allowed at this time.

An applicant must submit to the clerk's office, by mail or clerk's office drop box, the following:

- The completed application with a notarized original signature
- Original signatures of 2 attorneys already admitted to practice in this court
- Oath page signed with original signature (the requirement of in person signing is waived)
- Copy of Virginia Bar Card
- \$188 admission fee (checks or money orders only)
- \$20 fee for Certificate of Good Standing if requested

All signatures must be original. Photocopied, stamped, or computer-generated signatures will not be accepted.

Once a complete admission packet has been received the applicant will be contacted to acknowledge receipt of the packet.

Admission proceedings take place on Tuesdays before the duty docket and are currently being held via Zoom. These proceedings are limited in the number allowed.

The applicant will be emailed an invitation for admission when a date opens.

An attorney welcome packet that includes the certificate of admission, certificate of good standing (if requested), payment receipt, EDVA Attorney Refence Handbook, and CM/ECF registration information, will be mailed to the address provided on the application.
