POSITION OVERVIEW

The U.S. District Court for the Eastern District of Virginia is seeking qualified applicants for a full-time Temporary Law Clerk to United States District Judge Jamar K. Walker. **This temporary position is for a minimum of six (6) weeks beginning in February 2026 and is not covered by benefits.**

This position requires legal research and writing assistance, preparing bench memos, drafts orders and opinions, communicating with counsel regarding case management and procedural requirements, and assisting the Judge during courtroom proceedings.

MINIMUM QUALIFICATIONS

The Temporary Law Clerk manages a large docket of civil and criminal cases and has primary responsibilities regarding the drafting and finalizing of opinions and orders. This fast-paced "Rocket Docket" District demands excellent writing and analytical skills. The successful applicant must meet multiple deadlines in a timely and organized fashion and must be able to produce written materials (i.e. orders, opinions, etc.) quickly and accurately. Flexibility to meet demanding deadlines and a concomitant strong work ethic are both required. Candidates must maintain a courteous and professional demeanor within chambers, the Court, and the Bar, and before the public.

SALARY QUALIFICATIONS

JSP Grade 11 (\$75,038): Law school graduate, bar membership not required.

JSP Grade 12 (\$89,939): At least 1 year of legal work experience after the JD. Must be a member of the bar of a state, territorial, or federal court of general jurisdiction.

JSP Grade 13 (\$106,950): At least 2 years of legal work experience after the JD. Must be a member of the bar of a state, territorial, or federal court of general jurisdiction.

CONDITIONS OF EMPLOYMENT
